- Enclosed Vendor Hold Harmless / Insurance Agreement must be completed and submitted with your application.
- Vendors may begin setup at 9:00 AM on the day of the event.
- Vendors agree to remain open from 12:00 PM to 5:00 PM and may not sell prior to 11:00 AM.
- Vendors must submit a list of items for sale for review and approval. ByrdCage AC AC reserves the right to restrict or limit items to avoid excessive duplication among vendors.
- Each vendor is responsible for obtaining and maintaining a valid Mercantile License from the City of Atlantic City.
- Vendors are responsible for maintaining a clean and orderly booth space during the event and ensuring the area is fully cleaned upon departure.
- All fees are non-refundable. Failure to comply with event guidelines may result in termination of the vendor's relationship with ByrdCage AC and exclusion from future events.

- Returned checks due to insufficient funds will incur a \$35 bank fee, payable to ByrdCage AC.
- ByrdCage AC is not responsible for loss, theft, or damage to vendor property.
- ByrdCage AC reserves the right to deny rental or booth space at its discretion.
- Vendors acknowledge that all decisions made by ByrdCage AC and its representatives are final.
